<u>DocMagic Updating Lender Origination Type Requirements for</u> Multiple Forms

As part of DocMagic's <u>announcement</u> in October 2018, we will be making multiple form adjustments. As part of this change, DocMagic is adding print logic to 78 forms to consider an "origination type" of "Lender." In addition, we are also *removing* the consideration of "Lender" as an "origination type" from 19 forms which can be found at the bottom of this announcement.

This change comes as the result of an in-depth review of the state requirements for each form and will help our customers maintain the most accurate disclosure list possible when using our default settings.

As with our other announcements, the changes below are NOT new forms or changes to the form, but simply an update to the consideration of "origination type" (i.e. Lender, Broker, Correspondent) for generation. Note, these forms may have previously returned for any "origination type" but this update adds an additional check to return these forms when the "origination type" is Lender.

Customers can expect these changes to take effect as early as November 16, 2018. Should you wish for any of these changes to not appear in your specific plans, please reach out to your customer service representative to make that change.
